

### **Financial Agreement**

This is a financial agreement between you and the Mandel JCC of the Palm Beaches, Inc. (JCC) and is binding for the entirety of the program.

### **Registration and Fees**

Families are responsible for paying an annual non-refundable registration fee of \$75, in addition to annual tuition. The registration fee is due at the time of registration.

A non-refundable deposit of \$150 must be paid upon registration that is deducted from the  $1^{st}$  month payment.

## **Payment Information and Schedule**

Although you are allowed to pay your annual tuition in monthly installments, your signature on this agreement commits you to the full amount of annual tuition regardless of your child's attendance in the program.

Installments are payable by either ACH or credit/debit card only. MasterCard, Visa, Discover, or American Express are accepted; however, a 3% convenience fee will apply to all credit card payments. Installments are processed automatically on or around the 15<sup>th</sup> of each month beginning July 15, 2024. You are responsible for notifying the Children and Family Department of any changes to your payment information (lost or stolen card, expiration date changes, etc). If your ACH payment does not go through, we will charge the credit card on file. Payments that are declined by your bank will incur a \$100 service charge. Credit card declines will incur a \$72 service charge beyond the first occurrence.

Registration fees and deposits can only be made by credit card without incurring the 3% convenience fee. Monthly payments will be made by automatic ACH draft or credit card. A 3% convenience fee will be applied to all credit card transactions on reoccurring payments. If paying installments by ACH bank transfer, a valid credit card must be on file, and you authorize use of this credit card for any arrears on your account due to ACH failure or dispute.

In the event your JCC account is in arrears, your child will not be allowed to attend our Aftercare programming until such time as payment is made current.

Early withdrawal of your child from the JCC Aftercare Program does not excuse your obligation to remaining tuition payments; additionally, early withdrawal will result in forfeit of your deposit and any monies paid.



### **Cancellation Policy 60 Day Notice:**

The Mandel JCC requires a minimum of 60 days written notice to cancel any preschool or afterschool program agreement. Release of financial responsibility for accounts in good standing will take effect on the 1st day of the month occurring after 60 days. (Example: If you want to cancel and not pay for December, you must inform the Mandel JCC no later than September 30th in order to not get charged for December. If you give notice on or after October 1st, your cancellation would be effective January 1st.)

# **Program Participation Policies & Liability**

## **Program Participation Policy**

Participation in any Mandel JCC activity, program or use of any recreational facilities involves a risk of accidental injury despite safety precautions. Having been informed of the activities to be conducted by the Mandel Jewish Community Center of the Palm Beaches, Inc., the individual and/or parent and/or legal guardian of the participants assume all risks and hazards, incidental to the activities and release from all responsibility and agree to indemnify and hold harmless the Mandel Jewish Community Center of the Palm Beaches, Inc., its officers, directors, independent contractors, volunteers and all employees; as well as the Jewish Federation of Palm Beach County for any illness or injury to the individual or individual's children and/or family members occurring during their participation in any activities or use of any recreational facilities at or conducted by the Mandel Jewish Community Center of the Palm Beaches, Inc.

#### **Closure Policy**

If the Mandel JCC must close due to unforeseen circumstances including, but not limited to weather emergencies, natural disasters, threats, and global health emergencies for more than ten days, the participant will receive an account credit (not cash refund) for the days that were missed and additional payments will be suspended until the program resumes.

# **Vaccination Policy**

The Mandel JCC requires that all participants must be vaccinated and provide a current immunization record. The Mandel JCC does not allow for religious or personal exemptions. The only exemption allowed is from a medical doctor with full explanation as to why the child can't be vaccinated. Please note: Our current vaccination policy does not include Covid-19 vaccinations.

#### **Photo Policy**

The Mandel JCC may photograph and/or video children during their participation in programs at the Mandel JCC for promotional and/or documentary purposes. Promotional tools may include but are not limited to social media, website, and printed materials.



## **Covid-19 Policy**

Coronavirus, COVID-19 is a virus that spreads through person-to-person contact. Federal and state authorities recommend social distancing as a means to reduce the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in Mandel JCC's programs or accessing Mandel JCC's facilities could increase the risk of contracting COVID-19.
